### UNDERTAKING-CUM-INDEMNITY

#### SELF DECLARATION

I/We.....S/O,D/O,W/O.....R/o.....  
..... holding CNIC#..... do hereby irrevocably and unconditionally jointly and unconditionally solemnly affirm and declare as under.

1. That I/We am /are legal occupant of premises no. .... for which a New Electricity connection has been required in the capacity as the true and sole legal heir(s) (owner) on the basis of the documents of legal occupancy of the premises.
2. That I/We authorized Mr. / Ms. .... holding CNIC No. .... to submit the application on my/our behalf. I/We have no objection if the New Electricity connection is issued in the name of Mr. /Ms. .... S/o, D/o, w/o ..... CNIC ..... R/O ..... (Property address where Electricity connection applied).
3. I/We undertake to pay the dues, if any, found outstanding against any Electricity connection earlier obtained in the said premises.
4. That no unauthorized construction has been made in the premises subsequent to its original construction and there is no violation of municipal Bye-laws. Further K-Electric may withdraw/cancel the electricity connection in the event of any violation of Municipal Bye Laws.
5. That issuance of any KE bill in my/our name in respect of the above premises shall not in any way constitute any proof of title or ownership in respect of any other third parties.
6. I/we shall fully abide by the provisions of the Electricity Act, 1910 read together with NEPRA Act, 1997 and any rules and regulations made thereunder and furthermore shall abide by all HSEQ and other policies which are applicable from time to time by KE and which are more fully detailed in KE's website as if the same were expressly set out herein and incorporated by reference. I/we further undertake that that this Undertaking-cum-Indemnity is purely voluntary in nature and no threat/bribe/inducement or coercion has been placed upon me/us to supply this Undertaking-cum-Indemnity. Furthermore, time shall be of the essence of this Undertaking-cum-Indemnity and the same shall be in addition to any rights and remedies available to KE under the CSM, NEPRA Act, 1997 or Electricity Act, 1910 and not in derogation of the same.
7. It is also expressly understood that this undertaking-cum-Indemnity is personal in nature and does not enure to the benefit of any third parties or persons who are not expressly a signatory to this undertaking-cum-Indemnity. The provisions of this undertaking-cum-Indemnity are severable in nature and in the event that any provision of this Undertaking-cum-Indemnity is for any reason void, illegal or unenforceable, then it shall not affect the remaining provisions of this Undertaking-cum-Indemnity which shall continue in full force and effect, subject to K-ELECTRIC being at liberty to amend or substitute any such void, illegal or unenforceable provision through written intimation to us or on its website.
8. That I/we hereby indemnify K-ELECTRIC against any claims, demands, losses, damages or expenses of any nature whatsoever that it shall incur by reason of having relied upon this Undertaking-cum-Indemnity. Any demand by KE under this Undertaking-cum-Indemnity shall be final and conclusive for all purposes whatsoever and this Undertaking-cum-Indemnity shall be regarded as continuing in nature and shall not be affected by any partial demand from time to time that KE may make in its absolute discretion from time to time.
9. I/we further confirm that whatever is stated above is true and correct in all respects and no material information has been with-held or not disclosed by me/us to K-Electric. Furthermore, any documents submitted by me/us together with this undertaking-cum-Indemnity are true and correct and no forge or inaccurate document has been submitted to K-Electric.
