NOTIFICATION

S.R.O. 1774 (1)/2023- In pursuance of sub-section (7) of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), the Federal Government is pleased to direct that the following amendments shall be made in SRO No. 575(I)/2019 dated May 22, 2019, read with corrigendum dated September 23, 2019 and January 22, 2020, as amended and modified through SRO No. 1037(I)/2020 dated October 12, 2020, SRO 192(I)/2021 dated February 12, 2021, SRO No. 1429(I)/2021 dated November 05, 2021, SRO 1004(I)/2022 dated July 07, 2022, SRO 1175(I)/2022 dated July 25, 2022, SRO 977(I)/2023 dated July 27, 2023 and SRO No. 576(I)/2019 dated May 22, 2019, namely:

2. The Schedule of electricity tariffs determined for K-Electric and notified by Government of Pakistan vide above mentioned notifications shall be amended to the extent of Determined Schedule of tariff for K-Electric for the respective quarters vide National Electric Power Regulatory Authority decisions No's: NEPRA/TRF-362/K-Electric-2016/28918-28921 dated December 31, 2019, NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/13386-13388 dated March 10, 2021, NEPRA/R/ADG(Trf)/TRF-362/K-ELECTRIC-2016/3304-3306 dated March 01, 2022, NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/4511-4513 dated March 30, 2022, NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/9290-9292 dated June 8, 2022, NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/9296-9298 dated June 8, 2022, NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/13492-13494 dated July 22, 2022 and NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/20740-20742 dated October 24, 2022. Any difference between the rate recommended by NEPRA and the applicable consumer tariff notified in Schedule of tariffs, after accounting for the tariff adjustments in this notification shall be made available by way of subsidy.
3. Further NEPRA decision No. NEPRA/R/ADG(Trf)/TRF-362/K-Electric-2016/37540-43 dated November 22, 2023 also notified wherein, the Authority has decided to allow the recovery of Rs. 1.52/Kwh from the consumers of K-Electric, except life line, for a period of twelve months from December 2023 to November 2024. The recovery of such amount as collected by K-Electric shall be remitted to CPPA-G immediately under intimation to GoP.
4. Subject to the amendments made through this notification, all other provisions, terms and conditions contained in 575(I)/2019 dated May 22, 2019, read with corrigendum dated September 23, 2019, and January 22, 2020, as amended and modified through SRO No. 1037(I)/2020 dated October 12, 2020, SRO 192(I)/2021 dated February 12, 2021, SRO No. 1429(I)/2021 dated November 05, 2021, SRO No. 1004(I)/2022 dated July 07, 2022, SRO 1175(I)/2022 dated July 25, 2022, SRO 977(I)/2023 dated July 27, 2023 and SRO No. 576(I)/2019 dated May 22, 2019, shall continue to remain in full force and effect.
